## **GROUND & SHOW RULES**

- Coggins dated within 1 year of show date is required.
- 2. The ring and show grounds MUST be cleaned up before you leave the show grounds, this includes liter and animal waste.
- 3. NO running any horses around the outside of the ring.
- 4. Proper footwear is required for all riders.
- 5. Safety helmets are required for all riders under the age of 17.
- 6. All dogs MUST be on a leash.
- 7. NO bareback riding on show grounds except for the designed class.
- 8. A separate entry form must be filled out for **EACH HORSE & RIDER COMBINATION**.
- 9. Classes must be paid at the time of entry or a signed blank check to be given to the show Secretary.
- 10. There will be a \$25.00 free for any returned check.
- 11. NO REFUNDS for scratched classes.
- 12. Classes 1 & 2 MUST be entered 10 minutes prior to the start of the show and every other class must be entered before the start of that class.
- 13. A maximum of 5 minutes will be permitted for a requested tack change, after that the
- 14. Good Fellowship Riding Club had the right to split or combine any classes if it is felt necessary.
- 15.In order to school your horse, you MUST remove your back number.
- 16. All children's classes are 17 years of age & under as of the Jan. 1 of the current year.
- 17. All adult classes are 18 yeas of age as or older as of Jam 1 of the current year.
- 18. Open classes are for all ages (except if entered lead line classes).
- 19. The lead line classis divided 6yrs. & under, & & 8-year old. Children must enter only the class that is their age group. A 6-year-old cannot enter a 7- & 8-year class and vise versa. All leas liners can enter obstacle lead line.
- 20. Novice division is for riders in their first 2 teats of showing at the lope or canter.
- 21. All Green Horse is in the  $1^{st}$  and  $2^{nd}$  years of showing under saddle or if the horse is under the age of 5.

Good Fellowship Riding Club, its owners, and its agents will not be responsible for any accidents, illnesss; property damage, loss or theft incurred on the club grounds. The member(s) shall hold Good Fellowship Riding Club harmless and indemnify them against any legal proceedings arising from any accident or damages. Your signature on this form will release the Good Fellowship Riding Club and its owners of all said responsibilities.

- I, the undersigned (owner and rider if different, parent/guardian if owner or rider is 17 years of age or under) knowingly and voluntarily agree:
  - To assume total legal responsibility and hold harmless the Good Fellowship Riding Club, its owners; its agents and club management for any bodily injury or property damage sustained by me and/or my horse, equipment or rider on the club grounds or in the club rings.
  - To release the Good Fellowship Riding Club, its owners, its agents and club
    management of any legal responsibilities and to hold harmless the aforementioned for
    any bodily injury or property damage sustained by me/or my horse, equipment, or rider
    on Good Fellowship Riding Club property.

EQUINE ACTIVITY LIABILITY ACT WARNING: CAUTION: HORSEBACK RIDING AND EQUINE ACTIVITIES CAN BE DANGEROUS. RIDE AT YOUR OWN RISK. YOU ASSUME THE RISK OF EQUINE ACTIVITIES PURSUANT TO PENNSYLVANIA LAW. COVID-19 PROTOCOLS must be followed to permit the continued running of events. Anyone not complying with protocols may be asked to leave the grounds and forfeit their entry. As part of these protocols, I attest that:

- 1. I have not been exposed to any individual suspected to be suffering from COVID-19 or experiencing symptoms in the 14 days previous to coming onto the show grounds. (Except in the case that I am a health care worker and was wearing proper PPE at the time of exposure.)

For and in consideration of Good Fellowship Riding Club (GFRC) allowing me, the undersigned, to participate in any capacity in a GFRC event or activity, including but not limited to equestrian clinics, practices, shows, competitions and related or incidental activities and; I, for myself, and on behalf of my spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors, and assigns, hereby agree to and make the following contractual representations pursuant to this Agreement (the "Agreement"):

ACKNOWLEDGMENT OF RISK: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any GFRC Event involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other

participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the GFRC Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").

**ASSUMPTION OF RISK:** I understand that the aforementioned Risks may be caused in whole or in part or result directly or indirectly from the negligence of my own actions or inactions, the actions or inactions of others participating in the GFRC Events, or the negligent acts or omissions of the Released Parties defined below, and I hereby voluntarily and knowingly assume all such Risks and responsibility for any damages, liabilities, losses, or expenses that I incur as a result of my participation in any GFRC Events. I also agree to be responsible for any injury or damage caused by me, my horse, my employees or contractors under my direction and control at any GFRC Event.

WAIVER AND RELEASE OF LIABILITY, HOLD HARMLESS AND INDEMNITY: In conjunction with my participation in any GFRC Event, I hereby release, waive and covenant not to sue, and further agree to indemnify, defend and hold harmless the following parties: GFRC, GFRC members, Event participants (including athletes/riders, coaches, trainers, judges/officials, and other personnel), the Event owner, licensee, and competition managers; the promoters, sponsors, or advertisers of any GFRC Event; any charity or other beneficiary which may benefit from the GFRC Event; the owners, managers, or lessors of any facilities or premises where a GFRC Event may be held; and all directors, officers, employees, agents, contractors, and volunteers of any of the aforementioned parties (Individually and Collectively, the "Released Parties" or "Event Organizers"), with respect to any liability, claim(s), demand(s), cause(s) of action, damage(s), loss, or expense (including court costs and reasonable attorney fees) of any kind or nature ("Liability") which may arise out of, result from, or relate in any way to my participation in the GFRC Events, including claims for Liability caused in whole or in part by the negligent acts or omissions of the Released Parties.

**COMPLETE AGREEMENT AND SEVERABILITY CLAUSE**: This Agreement represents the complete understanding between the parties regarding these issues and no oral representations, statements or inducements have been made apart from this Agreement. If any provision of this Agreement is held to be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this Agreement and shall not affect the validity and enforceability of any remaining provisions.

I HAVE CAREFULLY READ THIS DOCUMENT IN ITS ENTIRETY, UNDERSTAND ALL OF ITS TERMS AND CONDITIONS, AND KNOW IT CONTAINS AN ASSUMPTION OF RISK, RELEASE AND WAIVER FROM LIABILITY, AS WELL AS A HOLD HARMLESS AND INDEMNIFICATION OBLIGATIONS.
